

# The decisions of XIX FIAS congresses

November 13 2008  
St.-Petersburg (Russia)

**Issue # 1.** The report of the FIAS president Mr. D. Rudman about SAMBO development.

**Listened to:**

FIAS President D. Rudman.

**Spoke:**

P. Stpilov (Bulgaria), M. Undaganov (Kazakhstan), P. Gorodnov (Czech Republic), V. Pirrella (Venezuela), F. Pulatov (Uzbekistan), S. Amzeev (Kazakhstan), M. Clark (England), S. Eliseev (Russia), R. Khislop (England), A. Birukv (Latvia), S. Bolle (Belgium)

**Have decided:**

- 1.1 To recognize an electronic mail communication as an official correspondence in FIAS.
- 1.2 To ratify distribution of an annual membership payment to FIAS (500 US dollars) in the following proportions: \$300 US dollars to FIAS and \$200 US dollars to continental federation.
- 1.3 To leave annual individual payment to FIAS at the rate of 25 US dollars.
- 1.4 To assign FIAS bureau (president, secretary general, vice-presidents of FIAS) to prepare the new version of the FIAS Statute in compliance with the IOC and AGFIS requirements till May 1, 2009, by directing it to national federations till June 1, 2009 for the subsequent discussion and acceptance on FIAS XX Congress.
- 1.5 To ratify the following changes in the existing FIAS Statute :

**Paragraph# 1** “*Federation International Amateur de SAMBO*” (FIAS) – is unique (sole), the only recognized international organization entitled to manage and develop SAMBO around the word.

FIAS – not governmental, not commercial (not for profit) organization, uniting national SAMBO federations.

SAMBO is the acronym derived from the Russian “self-defense without weapons” (samozashchitabezoruzhiya). The word “SAMBO” should be written in capital letters.”

**Paragraph# 3.4** The FIAS Flag represents logo FIAS at the centre of a rectangular on a light-blue background with inscriptions "Международная Любительская Федерация CAMBO" above the logo and «Federation International Amateur SAMBO" under the logo.

**Paragraph# 4.7** FIAS may accept the associative members - organizations or private persons, which render the practical help for SAMBO development.

The associative members have the right of a deliberative vote and can be elected by the FIAS Congress upon the recommendation of the respective National SAMBO Federation, or FIAS Executive Committee.

**1.6** Consider the proposition of revising the structure of the FIAS Executive Committee (i.e. approve 15 Executive Committee members, that will include FIAS President, Secretary General, 5 Vice-Presidents, 5 representatives from respective continental federations, FIAS Executive Director and Chief of Referee Commission) at the XX FIAS Congress.

**1.7** To reject the proposition to make subdivision of the participants of the World Championships into two subgroups (“A” for long existing federations medal-achievers, and “B” for newly-founded federations) and to keep existing structure

**1.8** To hold FIAS Congress two days prior to the beginning of competitions on a championship of the world, i.e. a day before official arrival day.

**1.9** To organize committee on a SAMBO history research consisting of a FIAS bureau responsible for collecting and summarizing historical documents of SAMBO development, in order to make presentation to the XX FIAS Congress.

**1.10** To carry out in 2009 not less than 10 doping tests.

**1.11** Rename World Championship among veterans for World Championship among Masters

**1.12** To consign the Executive committee to develop and utilize the ranking system for the participants of the Masters World Championship.

**1.13** All National SAMBO Federations should review the “Rules and Regulations of International Competitions” document (with changes and additions), distributed during XIX congress and send comments and recommendations to FIAS.

The comments and recommendations must be sent to FIAS no later than December 31, 2008. In case of absence of the remarks or recommendations to “Rules and Regulations of International Competitions” document will be considered as accepted.

## **Issue # 2. Acceptance of the new members**

### **Have decided:**

To grant Brazilian SAMBO Federation FIAS membership with the deliberative vote till presentation to the respective Continental SAMBO Federation for review an official and complete set of the registration documents according to the laws of the country.

After acceptance and approval of the registration documents by Continental SAMBO Federation, Brazilian Sambo Federation should be considering as a full member of FIAS.

This rule will be applied to any National Sambo Federation seeking FIAS membership as a new member.

### **Issue # 3.** The report of the FIAS treasurer

#### **Have decided:**

Not to charge National SAMBO Federations holding (organizing) World SAMBO Championship the fee.

The fee were assumed to pay for the trip and stay of the FIAS inspector - representative to inspect the place of competitions and report to FIAS Congress about the conditions and readiness to conduct the World Championship according to the FIAS requirements (“Rules and Regulations of International Competitions”).

To consign the Executive Committee to review this proposal and to present it to the XX Congress .

### **Issue # 4.** Calendar of competitions on 2009 - 2011.

#### **Have decided:**

**4.1** The Prize Fund of SAMBO World Cups should consist of participation fees (50\$ USD per person) paid to organizers by participants at each Stage of SAMBO World Cup.

**4.2** Participants from the country - organizer of a stage SAMBO World Cup are exempted from participation fee. (50 US dollars).

**4.3** A place of World SAMBO Championship Youth 20 12 (Uzbekistan or Romania) should be evaluated by Executive Committee of FIAS after reviewing the detailed list of conditions of the event not later February 1, 2009 and to notify on the accepted decision National Federations.

**4.4** To accept the proposals of National Federations to hold World SAMBO Championship among Masters ‘2009 in Israel, ‘2010 in France, and ‘2011 in Morocco.
