- Article 19.1. An Executive Group composed of the President, General Secretary, First Vice-presidents, Vice-Presidents can be formed for a more efficient resolution of problems.
- Article 19.2. The Executive Board of FIAS is composed of:
 - the FIAS President
 - General Secretary
 - FIAS First vice-presidents
 - Vice-Presidents,
 - Executive Board members
